Jeff Amero started the discussion by remarking that much had changed since the Commission had approved the Cambridge map on October 13, 2021. He noted that just today the Congressional maps had been voted and that they contained changes from the draft proposed Congressional maps which GIS had been using in working to minimize sub-precincts in Cambridge.

Mr. Amero then turned the presentation over to Mr. Sweeney who he indicated had started from scratch to see if he could reduce the potential number of sub-precincts in Cambridge.

Mr. Sweeney commented that they had worked to identify the common lines across all districts put forward by the State Legislature to minimize potential sub-precincts. He indicated that he had been able to reduce the number of sub-precincts to six prior to the release of the new Congressional maps.

Mr. Sweeney and Mr. Amero then commented where they saw potential issues with the approved Congressional maps noting that they, at first glance, appear to add at least three sub-precincts.

Commissioner Harris expressed her empathy for the work that GIS had done minimizing sub-precincts only to be impacted by the changes to the Congressional districts. She noted that we need to file by December 15th

which is not that far away. She asked when we could see the next iteration of the map.

Commissioner King commented that 2 Mt. Auburn is now in 6-2 which has a polling location at CRLS which could be difficult for seniors. He asked if GIS could look to include them in 4-3 which votes much closer. Mr. Sweeney commented that he was aware of the concern and would keep it in mind when revising the map.

Commissioner Marquardt commented that we should schedule a meeting for next week to review the revised map and keep the process moving forward.

Assistant Director Waxman noted that the drawing of the districts by the Legislature leaves little room for changes. Commissioners asked that she include that issue with the map when it is posted on-line.

Commissioner Harris asked if we need to focus on finalizing the map on December 8th for filing on December 15th. Assistant Director Waxman noted that the schedule mentioned would work and that we could also use the Secretary of State's office to create the description of the precincts as they have software to do that while we do not and using their help will save time.

1. Executive Director's Report

2. Assistant Director's Report
