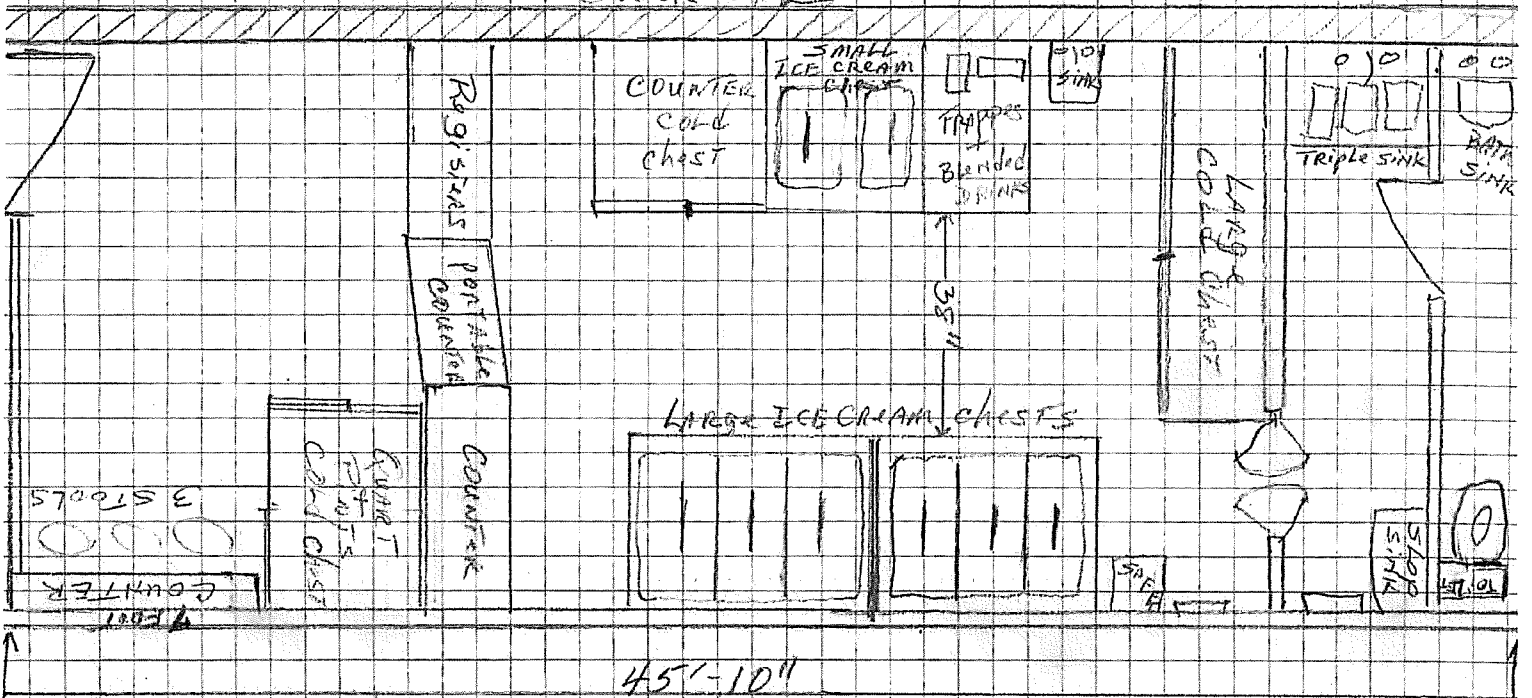

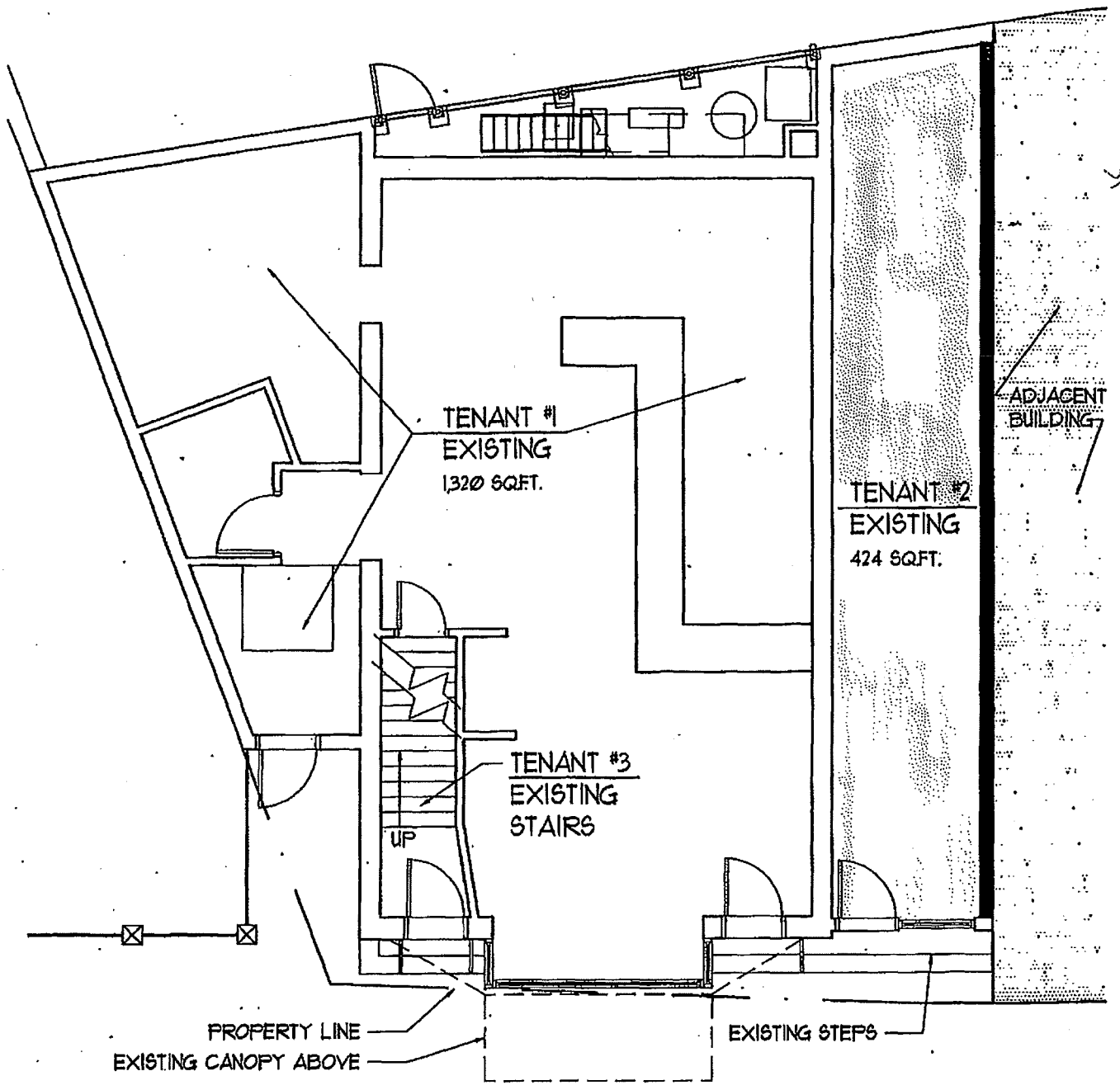

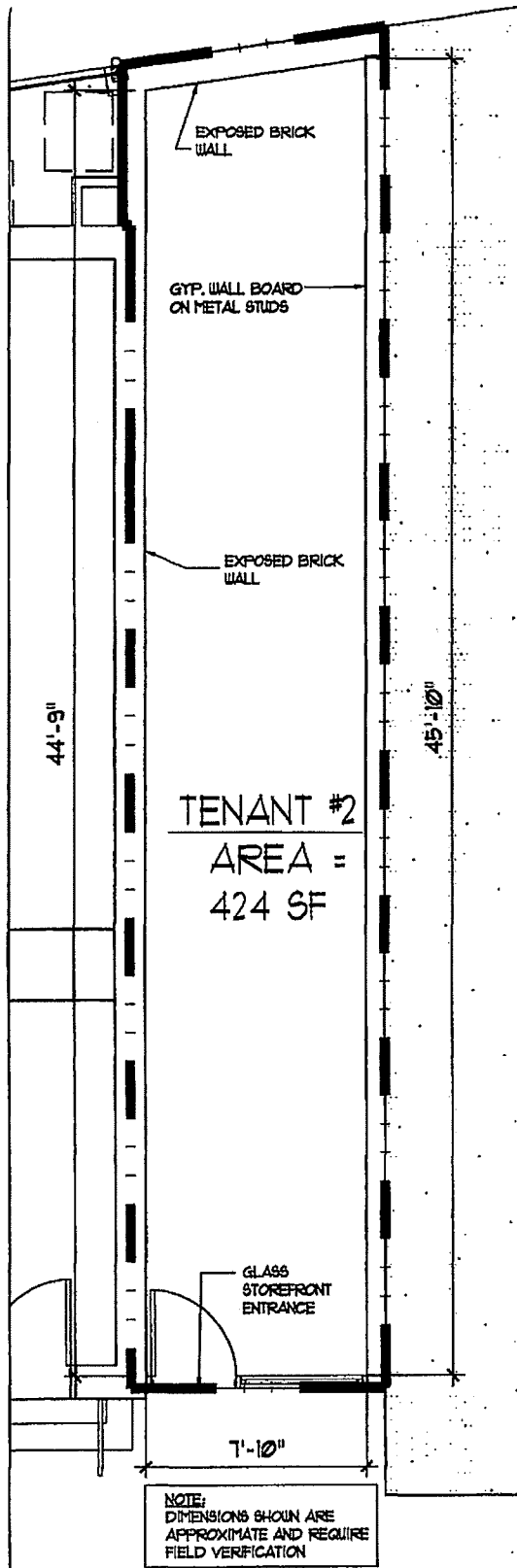

First Floor Plan

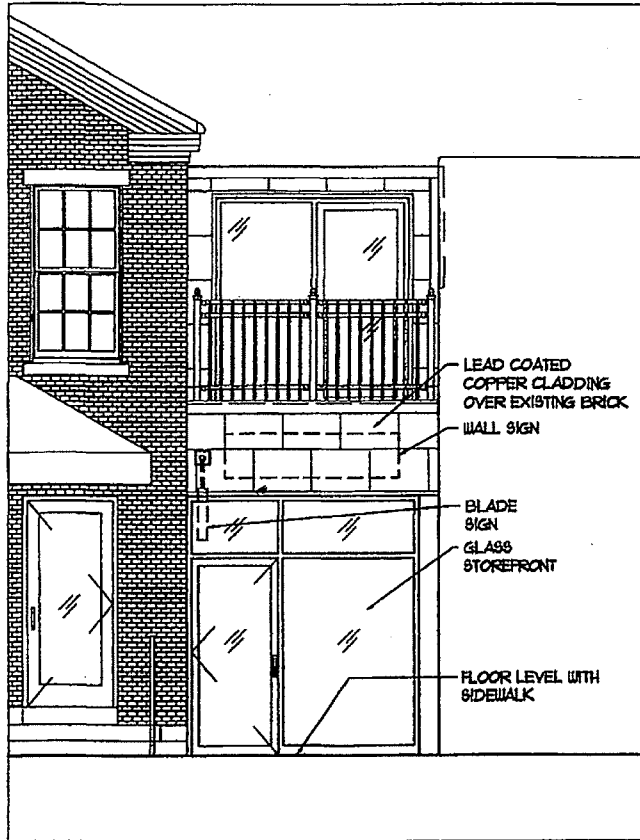
