Context of Committee

Context of Committee

City Goals, Policies and Ordinances

- VTRO
 - Vehicle Trip Reduction Ordinance, Cambridge commits to increasing the use of commuting alternatives and reducing trips in single-occupancy vehicles
- Climate Protection
 - Promote energy efficiency, Cambridge Energy Alliance, goal of 80% emissions reduction by 2050
- Vision Zero
 - City Policy (also a national and international initiative) focused on strategies to eliminate all traffic fatalities and severe injuries
- Complete Streets
 - Streets that provide safe and accessible options for all modes walking, biking, transit, personal vehicles, etc.
 - City Policy that guides projects in Cambridge

Context of Committee

City Goals, Policies and Ordinances (cont'd.)

- Envision Cambridge
 - Current citywide plan
 - Published after three-year planning and public engagement process
 - Provides a blueprint for the city's growth and change through 2030

2000 Pedestrian Plan

- Four major goals:
 - Provide policies and guidelines for improved walking facilities
 - Provide design standards for physical improvements
 - Outline steps to encourage walking
 - Provide an action plan to create an economical and efficient non-automobile transportation network
- Guides evolution of pedestrian facilities in the City

City Government Structure, State Government, and Role of the Committee

City Government Structure, State Government, and Role of the Committee

- City Boards and Commissions: role of advisory committees
- Committees subject to Open Meeting Laws and State Ethics requirements
- Key City departments
 - Community Development Dept. (CDD)
 - Traffic, Parking & Transportation (TP&T)
 - Public Works (DPW)
 - Health Department
- Key state agencies: MassDOT, DCR (Department of Conservation and Recreation), MBTA

Committee Logistics

- Communications and emails -> required reading
- Meetings → please arrive to committee meetings ahead of 6:00 so we can start on time
 - Agendas will be sent out with weekly email the week before the meeting
 - Minutes from prior meeting will be sent out at this time as well
 - Bylaws and Ground Rules
- Protocols for communicating
 - Internal communications (open meeting laws)
 - Communicating with others/in processes
 - May only represent the committee if an official position has been stated, otherwise may not imply you are speaking on behalf of the committee

Major Categories of Work

Major Categories of Work

- Infrastructure Projects
 - The committee forms an important part of the community engagement process for many projects
 - Provide feedback to City staff on specific projects and programs
- Development and private projects
 - The committee will sometimes perform reviews of ongoing development and private projects in Cambridge to evaluate how they line up with City goals and zoning requirements and City goals around walkability
 - Committee will sometimes write to the Planning Board with comments or suggestions



Major Projects in Progress

Major Projects in Progress

- River Street/Carl Barron Plaza
 - River Street is slated for a comprehensive reconstruction and redesign as part of the 5-Year Plan
 - Complete Streets project, aims to meet needs of all users
 - Also involves reconstruction of Carl Barron Plaza → public art, fixed and movable seating, upgrades to accessibility and transit and bike infrastructure
- Grand Junction Multi-Use Path
 - Multi-use pathway along the Grand Junction right of way from BU Bridge to Lechmere

Major Projects in Progress

- Mass4
 - Upgrading segments of Mass Ave between Dudley St and Porter Sq and between Porter Sq and Harvard Sq to comply with Cycling Safety Ordinance
 - Separated bike lanes required on Mass Ave, additional changes relating to pedestrians and transit
 - Some challenges with implementation
 - TriCommittee meeting to review February 16
- Linear Park and Danehy Connector (New Street)
 - New development on New Street on the edge of Danehy park
 - Project includes the development of new connections between site and Danehy Park, as well as between Danehy Park and the existing Linear Park
 - Improved Connection to Somerville Community Path
