Professor Stewart of MIT was introduced by Commissioner Harris. He thanked commission for all the work done by the commission. He had two asks, 1) wants to know if his students can work as poll workers, and 2) If students could perform an "observational study." In a prior study done in Boston, students were placed in a polling place for about two hours and performed several tasks with the goal to determine how long it took to vote. He stated it would be an academic exercise to take place in two precincts.

Commissioner Ward asked why he had stated the MIT would not be a good site. Professor Stewart stated it would be better for students to be in the community and away from their familiar surroundings and it would be better to be in a "higher traffic site." Commissioner Ward also asked did he have any feedback from the precinct workers as to how it worked to have students in their precinct? He responded students are instructed to be as in conspicuous as possible. Suggested large gyms are better for being less conspicuous. Commissioner Harris noted that she was glad a protocol would be in place regarding voters wondering what students were doing. She also asked how "high/low performing precinct." Were defined. He stated High clean modern facilities, big and bright. Low- places are those that have facilities challenges, such as low lighting, too small, and small Spaces. Commissioner Harris asked if students are expecting to be paired and prepared to work all

day? He thinks they would like to be paired. Also stated job sharing would be nice. Ms. Ford- asked was he referring to volunteer or paid work. Professor Stewart thinks paid is best. He stated the observational program would work as a fall back. Commissioner Marquardt noted Harvard Business School has election day off and MIT did not. Ms. Waxman stated we have a shortage of workers; we can take vote on hiring additional poll workers six weeks ahead of election without regard to voter registration status. Commissioner Marquardt stated getting additional poll workers would be very helpful. Using the university resources to make elections better is important. Commissioner Harris thanked Professor Stewart for approaching the election commission and she is very excited about this project and looking forward to working together.

#### III: REPORTS

#### 1. Executive Director's Report

Attended City Council meeting on September 12<sup>th</sup> regarding "Code Red." The city decided not to use Code Red. Ms. Ford stated there were comments made that we did not do enough to notify people about voting. Commissioner Harris asked if there is an option to create a notification about voting and if we can get on several lists the city use to notify residents about different issues such as parking, and trash pick-up. Ms. Waxman noted the election was noted in the daily update email twice in addition to the three city-wide mailings, social media posts, and press releases. Commissioner Marquardt added

that we put signs around the whole city. Commissioner Ward noted there was voting across the entire country, and it was in every major newsfeed, newspaper, and news cast, and stated the election office staff does a tremendous job make sure people know about elections in Cambridge. Commissioner Marquardt echoed those remarks and added the amount of information disseminated about various changes was a lot. He also added the amount of information people received was reflected in the lack of people going to the wrong polling places. He offered to reach out to Councilors to acknowledge their concerns and let them know we will be working to make it better. He also, noted we had tables at fairs. The deadline to receive ballots is November 12<sup>th</sup>, which is a Saturday at 5:00 pm. Ballots must be postmarked by 8:00 pm election day. Trying to coordinate pickups at the post office prior to 5:00 pm November 12<sup>th</sup>. CK will reach out to coordinate with the post office.

Ms. Ford will bring back election coordination meetings by working with City Manager's office. She talked with the City Manager, and he agreed there will be two meetings. The first to focus on all the details. The second to double check and make sure things don't fall through the cracks. This meeting will include all the city departments involved in elections. Commissioner Harris added maybe we can do a "debriefing" after the election. Presented a draft designated early voting location schedule (R-2). Commissioner King reported schools are closed on September 8<sup>th</sup>. Commissioner Harris pointed we should keep Saturdays 9am – 3pm. Ms. Waxman stated we need to vote today due to the deadline being is Sunday October 2<sup>nd</sup>. Commissioner Harris proposed at least one night to go later than 5 pm. Ms. Waxman noted that the number of people voting early is not great. CH will follow up on stuff in the drop box.

Commissioner King asked if we could get the fire apparatuses to keep from locking them every night. Commissioner Harris pointed out this is standard operating procedure in other jurisdictions. Commissioner Ward agrees with Commissioner Harris and do not think we need to ask questions every time we want to decide on a policy. Commissioner Marquardt asked if it is an issue closing drop boxes sooner is an issue since we can count ballots the next day. Ms. Waxman stated if everything is the same as it was in the November 2020 election, we do not have to take all the ballots to the polls on election night and can count them later when we count the ballots that come in and are marked before 8 pm election night the following Monday. The only issue is having someone at the drop boxes to lock them at 8 pm. Commissioner Harris asked when ballots are expected to be sent to local elections offices. Ms. Waxman stated she was told by the Secretary of State's office between now and October 12<sup>th</sup>. Commissioner King asked how many requests do we have in the que from September for November? Commissioner Marquardt asked if ballot question fit on the ballot. Ms. Waxman replied yes, either the front or front and back. No ballots styles required a second page. Commissioner Harris will follow up on fire apparatuses for drop boxes.

She also got feedback from poll workers regarding Lexington Ave. firehouse, 1) Voters will be entering through the main door which means workers will need some sort of heating device, 2) People were slipping due to rain/wet floor in 9-1. This issue needs to be address before the election.
