

New Business Commissioner Harris stated she will ask her workers if they have any comments about how the primary went in case there needs to be adjustments. Commissioner Ward asked how commissioners thought the election went for the workers. Commissioner Harris stated it was a light turnout and for the workers it was not as intense as it could have been. Polling places had good coverage. Took more time because of the sub-precinct procedures. Commissioner Marquardt concurred and added we should consider doing the sub-precinct training it in person. He also stated we should do whatever we can to limit the number of ballots delivered to the polls the end of the night. He also suggested to work with the Public Information Office to educate the public on not dropping off their ballots at the last minute. Commission Harris suggested if the state could give more time to process ballots it would make it easier. Commissioner King commented on the number of resources being expended on very few ballots being collected during early voting. Commissioner Marquardt added we must look at our procedures for early voting, particularly since we are going to 14 days vs 7 days. Commissioner Harris suggested we should be guided by what the data says about number of drop boxes needed.
