The Planning Board of the City of Cambridge

will hold a public hearing on **Tuesday, May 21, 2024 at 6:30 p.m.**

held remotely (see below for instructions to participate)

on a Zoning Petition by Joseph S. Ronayne, et al.,

to amend the Cambridge Zoning Ordinance in Articles 4.000, 5.000, and 8.000

with the intent to allow multifamily residential uses across the city and eliminate footnotes that further restrict residential development within fully residential districts and to bring Res A and B uses in line with existing Res C uses, making multifamily uses both permissible and feasible.
