











- 5. WATER UTILITY SHALL CONFORM TO THE CITY OF CAMBRIDGE WATER DEPARTMENT CONSTRUCTION AND OPERATING PROCEDURES MINIMUM CRITERIA AND DETAILS.
- 6. ALL EXISTING TREES ARE TO BE RETAINED AND PROTECTED DURING CONSTRUCTION, IN ACCORDANCE WITH PROJECT SPECIFICATIONS, UNLESS OTHERWISE NOTED ON THE PLANS. ALL EXISTING TREES TO BE TRANSPLANTED SHALL BE COORDINATED WITH THE CITY LANDSCAPE ARCHITECT PRIOR TO REMOVAL. PLACEMENT AT FINAL LOCATION SHALL BE AT THE DIRECTION OF THE LANDSCAPE ARCHITECT. CONTRACTOR SHALL ASSUME 30 TREES TO BE TRANSPLANTED.
- 7. CONTRACTOR SHALL REMOVE AND DISPOSE OF EXISTING BITUMINOUS ASPHALT, IN ACCORDANCE WITH PROJECT SPECIFICATIONS, AT ALL LOCATIONS OF PROPOSED ASPHALT AND WITHIN THE LIMITS OF WORK AS SPECIFIED ON THE PLAN.
- 8. EXISTING GRAVEL BORROW SATISFYING GRADATION REQUIREMENTS SHALL REMAIN IN PLACE. UNSUITABLE MATERIALS SHALL BE REPLACED WITH GRAVEL BORROW FOR BASE COURSE, ITEM 151. RECLAIMED BORROW MATERIAL SHALL CONFORM TO MASS DOT STANDARD SPECIFICATIONS AND SHALL MEET THE REQUIREMENTS OF MASS DOT M1.09.0 RECLAIMED PAVEMENT BORROW MATERIAL, ITEM 404.5.
- 9. LOCATION OF TEMPORARY TREE AND PLANT PROTECTION FENCE SHALL BE COORDINATED BETWEEN THE CONTRACTOR AND THE CITY LANDSCAPE ARCHITECT. CONTRACTOR SHALL SUBMIT A WORK PLAN TO THE CITY AND ENGINEER FOR APPROVAL OF FENCE LOCATIONS PRIOR TO THE INSTALLATION OF FENCING AND PRIOR TO THE START OF ANY EARTH DISTURBING ACTIVITIES.
