Instructions for Providing Public Comment During CCPD Meetings via Zoom

Anyone wishing to address the Cambridge Commission for Persons with Disabilities (CCPD) during the Public Comment section of the agenda may indicate that by "raising their hand" virtually within the Zoom platform. The host (CCPD staff) will call on members of the public to speak in the order in which their hands were raised. Please note that while you may raise your hand at any point during the meeting, you will not be called on to speak until the Public Comment period of the meeting.

To raise your hand:

- On a Mac or PC:
 - Click "raise hand" in the webinar control panel
 - Alternatively, you may you the keyboard shortcut to raise and lower your hand:
 - Windows: press "Alt+Y"
 - Mac: press "Option+Y"
 - When you are called on by the host to speak, you will be prompted to unmute your microphone (you must unmute yourself, as the host does not have the ability to unmute individuals).
 - After you have spoken or once your 3 minutes are up, your microphone will be muted by the host
- If you are calling in by phone:
 - Press *9 to raise and lower your hand
 - When you are called on to speak during the public comment period, you will need to press *6 to unmute yourself (press it again to mute yourself)
 - Note: your phone number will be visible to only the host of the meeting (CCPD staff). Because your name will not be displayed, we will call on you when it's your turn to comment by using the last four (4) numbers of your phone number to identify you. For example, "The person calling in from the number ending in ####, you may now provide public comment."
 - After you have spoken or once your 3 minutes are up, your microphone will be muted by the host

Once they have the floor, members of the public are asked to identify themselves, and each speaker is limited to not more than three (3) minutes. Although the public comments should, whenever possible, address one or more items on the agenda for that particular meeting, if time permits, the Chair may allow a speaker to comment on matters that may not directly address an item on the agenda, but do concern the Commission.

Minutes for Thursday, September 14, 2023 CCPD Meeting

Online via Zoom

Meeting was called to order at 6:07 PM

Present:

Announcements:

- The MA Department of Public Health is doing a statewide health needs assessment of people with disabilities, including an online survey
- Alice Wong has an interesting blog post on her website about the BU School of Public Health asking her not to speak about certain things during the presentation many of us just watched
- MA Department of Transportation is holding a public meeting on the planned Eliot Bridget Preservation work on September 21 at 6:30 PM at the Fiorentino Center, 123 Antwerp Street, Allston, MA

Minutes

- A motion to approve the May minutes was seconded and passed unanimously
- A motion to approve the June minutes was seconded and passed unanimously

Working Group Updates:

- Avril reported that the community outreach group met with Kate and Rachel and some staff from the Boston
 Disability Commission. The Boston Commission has a much larger staff (11), including dedicated outreach staff.
 They do three main events each year:
 - A town hall meeting for the disability community
 - A civic engagement event teaching residents how to become involved and provide public input to the City of Boston
 - ADA Day each July celebrating the anniversary of the passage of the Americans with Disabilities Act
- A few members expressed interest in learning more about the work of the Boston Commission. It was noted that their monthly meetings are open to the public.

Public Works Update:

Jerry reported the following:

- This is Jerry's last CCPD meeting, as he is being moved to the Bicycle Committee. He introduced Melissa Miguel, another Senior Supervising Engineer at DPW who will be taking his place on the CCPD advisory board.
- The Inman Square project is complete, with new traffic patterns and crosswalk improvements.

- Gore Street reconstruction in East Cambridge is essentially complete, with lots of sidewalk improvements and a multi-use path.
- Pedestrian improvements on Belmont Street near Mt. Auburn are almost finished.
- There is a new park under construction on Binney Street in the Kendall Sq area. They are working on landscaping and the installation of a path through it.
- North First Street now connects Cambridge Crossing with the rest of First Street south of Lechmere MBTA station. This opened in June
- River Street reconstruction is still in process, with lots of utility work going on. Getting closer to Central, some pedestrian re-routing will happen.
- There will be a formal presentation coming later this fall on the Mass Ave Partial Build project, which a partial redo of Mass Ave from Cambridge Common to Alewife as part of Cycling Safety Ordinance
- Chapter 90 projects, which are misc. projects, include Huron Ave with bike lane improvements, Park Ave, Walden St., Webster St.
- The Five-Year Street and Sidewalk Plan has been updated and will be presented at an upcoming meeting.

Updated from the Cambridge Economic Opportunity Committee (CEOC)

- Rachel Plummer, Associate Director of CEOC, reported that they are hosting a City Council candidate forum on Thursday, October 12th at the YWCA at 7 Temple Street from 6-8PM. The building is accessible. Planning to provide CART captioning. They are hoping that CCTV will be able to film and broadcast and help them make it a hybrid event. They will also have interpreters for Spanish, Haitian-Creole, Bangla, and Amharic speaking audience members.
- The format is still in flux, but there will be a survey sent to candidates ahead of time to be completed in writing.
- CEOC staff met with Kate and Rachel to discuss how to make the forum as inclusive as possible for people with disabilities. Kate and Rachel recommended that everyone use microphones when speaking, and having people say their names when they speak
- Kate noted that the forum conflicts with the October CCPD meeting. If folks were interested in rescheduling our meeting so they can attend the forum, that can be done.
- This forum has been held during past election cycles. In the past, it's been held at the Senior Center. CEOC is hoping more people will come with it being held at the YWCA.
- There are 24 candidates running. In the past, almost everyone has attended, so likely to have 20-24 candidates in attendance.
- Members raised issues they would like to see discussed at the forum:
 - Providing more support for children with disabilities in out of school time programs
 - The need for more accessible & affordable housing
 - A desire for disability housing that is separate from senior housing and making disabled housing more inclusive.
 - The shortage of PCAs/home health aides and the possibility of creating a home health aide program.

Staff Report:

Rachel reported the following:

- Rachel thanked Jerry for his 7 years as a CCPD member and DPW liaison and welcomed Melissa Miguel as our new liaison
- Rachel will check in with Ellen about moving the October CCPD meeting so that members may attend the City Council Candidate Forum.
