Old Business

March 5, 2024, Election Debrief

Commissioner Harris led a discussion on the feedback received from Poll Workers regarding the use of Poll Pads for voter check-ins on Election Day. The advantages and disadvantages of utilizing Poll Pads were examined. Another significant point of discussion was the establishment of a portal for individuals interested in working during elections. Additionally, the idea of creating a dedicated student link to engage students in poll worker opportunities was also mentioned.

Commissioner Marquardt inquired about the possibility of reducing the weight of ballot carriers to facilitate easier transportation on Election Day.

The question was raised by Commissioner Harris regarding whether the Commissioners should personally deliver the Poll Pads and the ballot scanners to their designated locations.

Commissioner Ward raised concerns about the logistical feasibility of delivering scanners to all precincts by 6 a.m. on Election Day.

Commissioner Harris will be sharing links for the municipalities she looked into.

V. New Business

Assistant Director Waxman inquired about firming up the inclusion of 7-3 at the CRLS location.

Assistant Director Waxman will provide us with the contact information for the CRLS point person.

Executive Director Ford proposed that the Board begin to think about Early Voting locations for the upcoming September 3, 2024, primary election.

The Executive Director highlighted the necessity of addressing police coverage for polling locations which will need to be approved by the City Council meeting, emphasizing the importance of initiating planning early.
