Harvard University requests a 5-year extension to the Temporary Certificate of Appropriateness for a temporary office trailer and shed at 41 Winthrop Street, approved first in June 2012, extended in 2014 and in 2019. The proposal is to maintain the east trailer and the shed, while the west trailer is no longer needed and will be removed in August 2024. The lawn in that area will be replaced to its pre-existing condition. The east trailer is essential as work space for field staff and A/E teams supporting the ongoing renewal of the undergraduate dormitories in Harvard's River House area. The shed serves as necessary landscape equipment storage. The lawn and fence will be restored when they are removed.

To date, Harvard has successfully completed 6 House Renewal projects. The 7th project is in progress, anticipated for completion in 2025. Two upcoming House Renewal projects are in planning.

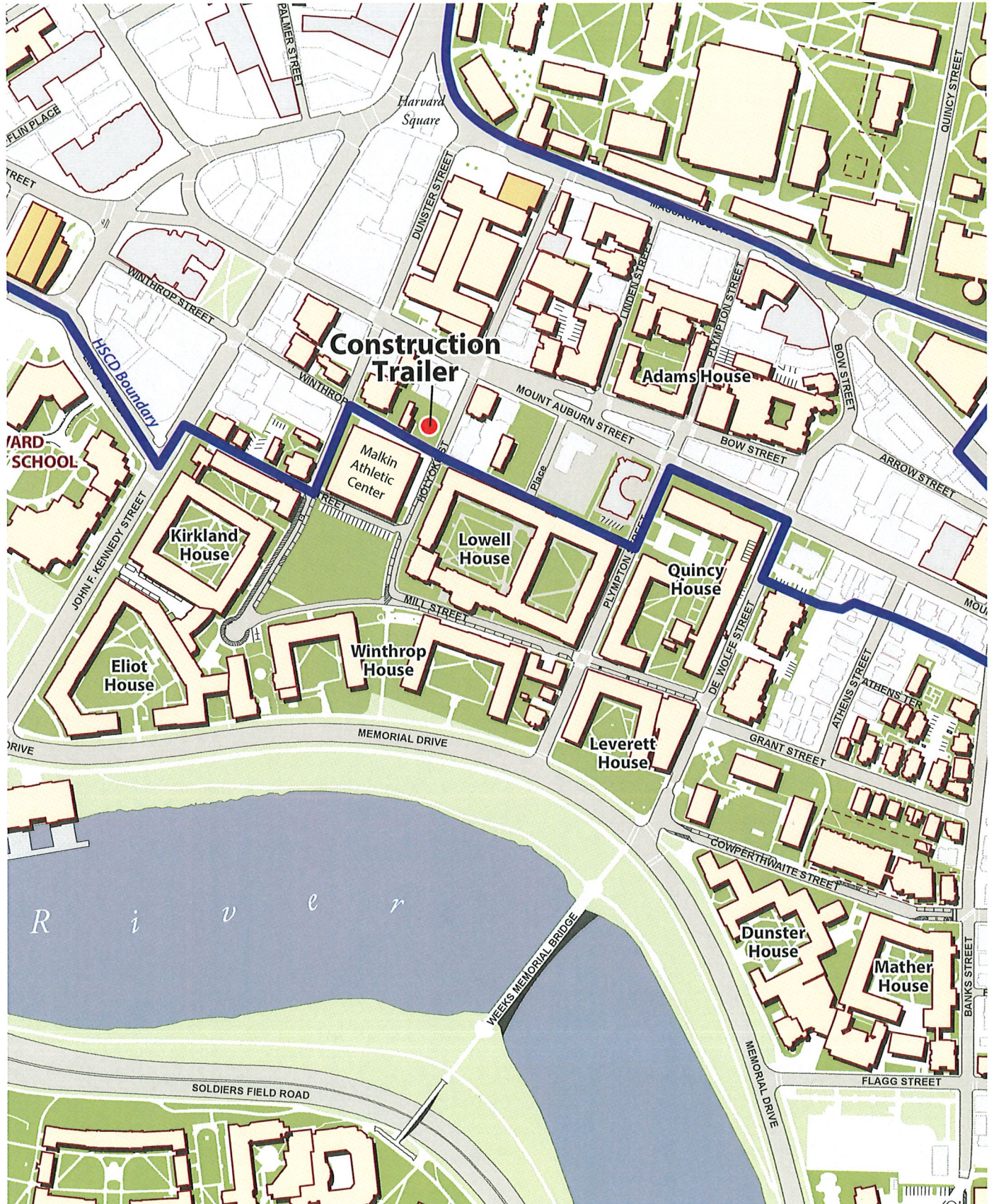

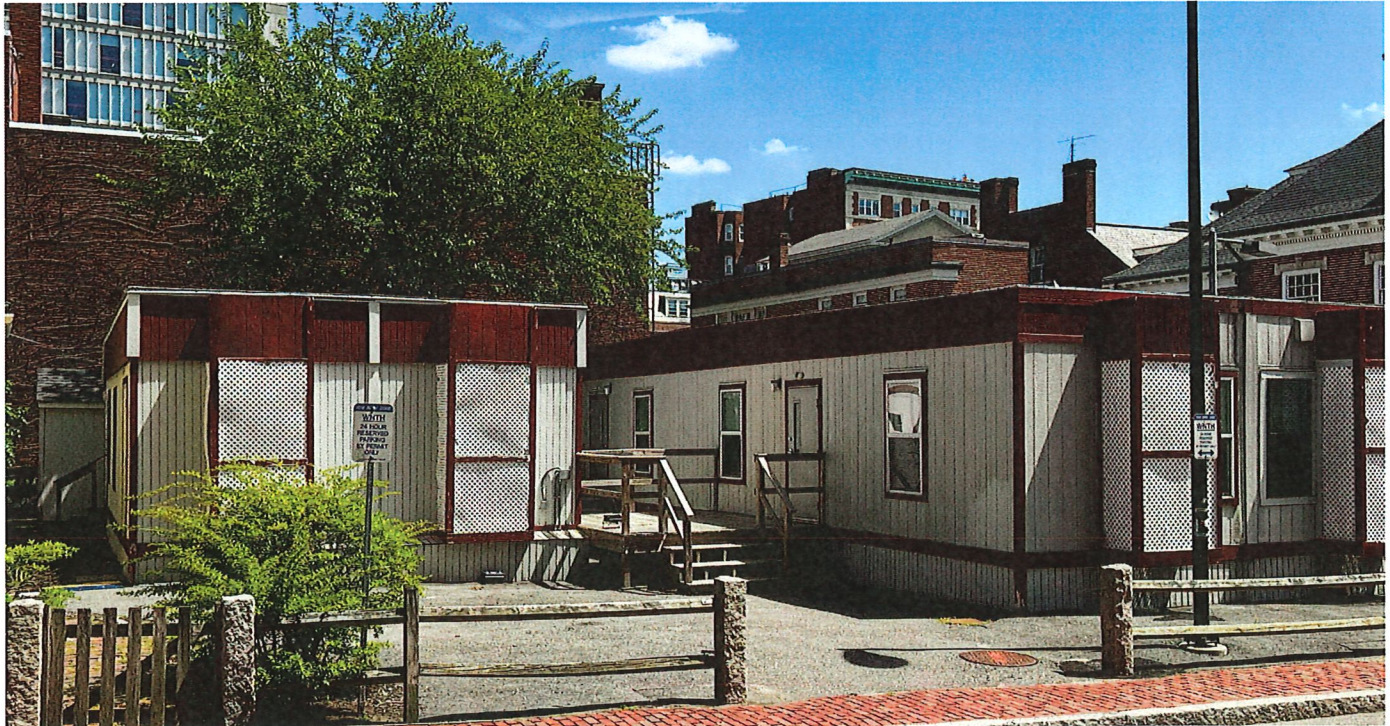
