BOARD OF LICENSE COMMISSIONERS MEETING MINUTES

Tuesday, May 21, 2024, 11:00 a.m. By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

Board Members (All Present): Nicole Murati Ferrer, Christine A. Elow, and Thomas Cahill, Jr.

Staff Member Present: Christopher O'Neil.

Decisions: All decisions, unless otherwise stated, were 3-0, and by roll call.

Public Testimony Matters

1. Disciplinary Interstate Management Company, LLC d/b/a The Charles Hotel, 1 Bennett Street, Innholder All Alcoholic Beverages License #10894, for alleged violations of serving, selling and/or delivering alcohol to an intoxicated individual and/or overservice of alcohol on January 31, 2024 and February 1, 2024, in violation of G.L. c. 138, §§ 23, 64-64A, 69, G. L. c. 140, and Board's Rules 2, 12B.6, and 12B.7.

Decision: Rescheduled to second meeting in June.

2. Disciplinary Tria Cambridge Concessions, LLC d/b/a Freepoint Hotel, 220 Alewife BrookParkway, Common Victualler and Entertainment All Alcohol License #11569, for alleged violations of serving, selling and/or delivering of alcohol to an intoxicated person and/or overservice of alcohol on (insert date) in violation of G. L. c. 138, §§ 23, 64-64A, 69, G. L. c. 140, and Board's Rules 2, 12B.6, and 12B.7.

Present: Attorney Andrew Upton; Kelly Ford; Kyle Goodsell; Hiram Negron; Joey Blanck; Investigator Joseph Kelley.

Documents Considered: Hearing notice, and documents attached thereto; and file.

Summary: The Cambridge police reported and found two individuals at the bar, who were unsteady on their feet, took them about 5 minutes to get up, and the police became concerned for their well-being and safety. Both were guests of the hotel, father and son, and refused medical attention. Between the two, they consumed 14 alcoholic beverages in 90 minutes: 7 Grey Goose, and 7 Jack Daniels.

Licensee did not deny that there was overservice; they stated the data clearly established there was overservice. The bartender got too friendly with the clients; bartender resigned under pressure during internal investigation – the company did not feel like they could be retrained or rehabilitated. Manager of record, Daisy Chai was terminated as she was not found to be a good fit. A new manager

has been hired and an application for change is imminent. The entire situation has the attention of the company. The new manager has about 14 years of experience in the industry. They are also looking to see whether they need to reinforce their current training program.

Decision: Under advisement.

3. Application #267061 Central Sandwich, LLC d/b/a The Smoot Standard, 313 Massachusetts Avenue, has applied for a new Common Victualler All Alcohol License with seating for 78 inside, a total occupancy of 98 and proposed hours of 7:00 a.m. to 1:00 a.m. all days with alcohol service starting after 10:00 a.m. on Sunday and after 8:00 a.m. Monday through Saturday. Alexander Tannenbaum as proposed Manager of Record of a premises described as: Restaurant located on ground floor with bar, dining room, and kitchen, with one entrance and one exit. Additional seating located on mezzanine.

Present: Patrick Conte; and Alexander Tannenbaum.

Documents Considered: Application submitted, and documents attached thereto.

Summary: The public need is presumed because there used to be an all alcohol common victualler at the location. It closed not due to lack of need but rather a personal decision of the previous owner. There is a current need also because of all the construction in the area (business offices). They plan to be a café during day and more traditional restaurant at night. They want music above conversation level for special and listening events. They are also seeking outdoor seating on the public way – 16 seats and same hours as indoors. There will be no entertainment outdoors.

Alexander Tannenbaum has extensive experience in the food and beverage industry with no disciplinary issues with the local board or ABCC. Is familiar with the rules and regulations of the Board, ABCC and laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Tannenbaum provided TIPS certificate as proof of training in the safe service and sale of alcohol.

The premises description was updated to: A/k/a 311-313 Massachusetts Avenue. Restaurant located on ground floor with bar, dining room, and kitchen, with one entrance and one exit. Additional seating located on mezzanine. Storage located in basement. Outdoor seating on the public sidewalk.

Decision: Granted with amended premises description to include basement and also outdoor seating on the public way.

Summary: This is for the restaurant operation at the hotel. Colette, which is the current restaurant, currently is being operated under a management agreement. Rebekah Barrs is taking over and has extensive experience. The current operator and owner will go out, and Rebekah Barr will come in. Manager of the hotel remains the same. The operation will continue to be a French style bistro. Barr has been working at the location about 45 days and running the restaurant. Barr will buy the business as the current owner recently had a child and is consolidating their businesses. Barr intends to reinstitute the breakfast hours and have more events. Barr has over 10 years of experience in high end and upscale dining, in Maine NH and TN and Boston area.

Decision: Granted.

7. Application #255845 O912, LLC d/b/a Forage, 5 Craigie Circle, Common Victualler All Alcohol License #11566, for an Alteration of Premises to include a seasonal outdoor patio on private property. The proposed premises description is: Restaurant at basement level, one main dining room with bar

(approx. 1200 sq. ft.) with storage in the rear (approx. 550 sq. ft.). One main entrance on Craigie Circle and one rear service entrance. Includes patio on private property of approximately 330 sq. ft.

Present: Stanislas Hilbert.

Documents Considered: Application submitted, and documents attached thereto; and file.

Summary: They had an outdoor area in the private parking lot and are seeking to move it to another private area but not on the parking lot but rather in front of the building. The plan shows 20 seats but they are probably only doing about 18 seats. The area is not visible from the inside and they will have somebody on the patio as a manager. Will have the same hours of operation as indoors. This new location has gone through the variance process.

Decision: Granted with the condition that while patio is open to the public, there must be a manager/employee dedicated to monitoring the area.

Associates, Inc. d/b/a Royal East Restaurant, 782 Main Street, Common Victualler All Alcohol License #11272, for an Alteration of Premises to include a seasonal outdoor patio on public property. Approximately 810 square foot patio on public property on the sidewalk and into the parking lane.

Summary: Had a patio during COVID but did not seek to make it permanent until now. The SSBU has not yet issued but in the process. They will have 28 seats and the square footage than what was listed on the agenda – it is only about 456 sq. ft. They will have the same hours as indoors and it can be seen from indoors.

Decision: Granted with amendment to the premises description that the total square footage of the patio is 456 sq. ft. patio; 28 seats; same hours as indoors; and pending issuance of SSBU and subject to any conditions and modifications therein.

Present: Panupak Kraiwong.

Summary: This is Unit 1 of 1906 Massachusetts Avenue. Panupak Kraiwong has other restaurants in Somerville and Boston. This will be his fourth restaurants. Kraiwong has been manager of record with no disciplinary issues with the local board or ABCC. Kraiwong is familiar with the rules and regulations of the Board, ABCC and laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Kraiwong is TIPS certified and will upload it.

Kraiwong believes there is a need to have beer and wine with the Thai food offerings to provide more options to the customers. The market research shows that the customer base of that area seek those types of options. When they first applied they knew the sprinkler system had to be updated prior to being able to apply for alcohol. Now that the work is completed, they are moving forward with the alcohol component of the business.

Application #262880 First Street Cuisine, LLC d/b/a First Street Market, 55 First Street, for a new Common Victualler All Alcohol License with seating for 290 inside and proposed hours of 7:00 a.m. to 11:00 p.m. all days with alcohol service starting after 10:00 a.m. William Gilson as proposed Manager of Record of a premises described as: 6,000 sq. ft. containing a counter service cafe with seating, a bar and a market/event space. Applicant is also applying for an entertainment license to include live music with amplification and recorded music above conversation level with amplification.

Present: Andrew Upton, attorney; and William Gilson.

Documents Considered: Application submitted, and documents attached thereto. Correspondence in support of application.

Summary: This is in a new development, owned by the City. They City approached them and sought out this type of business. This is a unique concept that will provide a service to the public that is needed and wanted. The location is built so that there is a restaurant with a year-round farmers' market attached to it. The portion of the restaurant is the smallest of the two. – the restaurant is about 3,000 sq. ft. and the farmers' market/event space is (which is considered "flex space") is about 6,000 sq. ft. There are small outdoor benches, about 25-50 feet of outside space but there is no way to serve alcohol or food in the space. Per the lease they will be responsible for maintaining it, but thay have no intent to use it as part of the premises (no food or alcohol service). All of the seating in the restaurant space is permanent, the market/flex space has various configurations. The total maximum capacity for the entire area is 290.

William ("Will") Gilson has extensive experience in the food and beverage industry, with no disciplinary issues with the local board or ABCC. Gilson is familiar with the rules and regulations of the Board, ABCC and laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Gilson provided TIPS certificate as proof of training in the safe service and sale of alcohol.

Decision: Granted with amended premises description: A total of approximately 9,000 sq. ft. on the first floor. The space is divided in two portions: 3,000 sq. ft. is the restaurant portion of the premises; and 6,000 sq. ft. are the farmers' market/flex/event space.

13. Disciplinary Ethos Business Partners, Inc., d/b/a Le's Sushi Bar and Restaurant, 425 Cambridge Street, Common Victualler All Alcohol License #12289, allegations of transferring the beneficial interest of the license or making changes to the holder or manager of record without approval, and/or for making false statements in the license renewal application in violation of G. Summary: The owner of the business, Huong Le, did not appear at the hearing. The two persons that appeared are the proposed owners of the business that is trying to legally take over the license and the space. There is no contention that the business was sold, payment has exchanged hands

and the premises is currently not under the control of the current licensee. Le was aware of the hearing but chose not to attend. Athis matter has been ongoing since at least November 2023 and the licensee has been given ample time to come into compliance.

Decision: Violation as to all counts, license indefinitely suspended.
