Decisions: All decisions, unless otherwise stated, were 3-0, and by roll call.

Public Testimony Matters

1. Application #1141154 PAJ 2002 Corporation d/b/a Nine Tastes, 50 JFK Street, Common Victualler Wine and Malt License #11247, for a Change of Officers/Directors and a Change of Stock Interests.

Present: Attorney James Rafferty; Patrick Conte; and Sadayut Chinporn.

Documents Considered: Application and documents attached thereto.

Summary: Changes to the beneficial interest holders. Change of ownership involves the transfer of two current members, there is a third member who passed away, the estate is currently being worked on so her interests are not being asked to be transferred at this time but will be done so once the estate clears. Principal interest holder is transferring all of his ownership to his sister who currently serves as the president of the corporation with no interest, then Panja is transferring the interest to 2 different individuals. The business has been in operation since 2002 and will continue to operate as is. There are no changes to manager of record.

Summary: [2nd call] Andre is in charge of opening the stores but will not be present or working at the store. They will operate as 2nd Street and sell clothing and shoes. They have about 800 stores in Japan and some in the United States; this would be the first one in Massachusetts. They are familiar with the rules and regulations of a second hand good store including the registry and age of seller requirements. Seiya is the manager of this region – they too are not working at the premises or will be on site. They will hire a manager but do not have one yet.

Decision: Granted (2-0), with the condition that prior to the license issuing we need the name, email and phone number of the manager of the store.

3. Application #288316 JSM736 Group, Inc. d/b/a BB.Q Chicken, 736 Massachusetts Avenue, for a new Common Victualler Wine and Malt Beverages License with seating for 24 and proposed hours of 11:00 a.m. to 10:00 p.m. Sundays, 11:00 a.m. to 11:00 p.m. Monday through Thursday, and 11:00 a.m. to 2:00 a.m. Friday and Saturday. Ziming Wen as proposed Manager of Record of a premises described as: Approximately 800 sq. ft. The restaurant has one room on the first floor with a kitchen and storage in the rear and basement. There is 1 entrance, 2 exits.

Present: Attorney Russell Chin; and Ziming Wen.

Documents Considered: Application and documents attached thereto.

Summary: This location has a common victualler license – the current license also has an outdoor area on the public way. They will want the outdoor included as licensed premises too. They are a small restaurant and want to be able to offer the same amenities as surrounding restaurants. They have also been asked by patrons for beer and wine and especially at night. Their clientele come from the university and they like to have some alcohol with their dinner. Also, for the customers beer and chicken are a good combination.

Ziming Wen has experience in the food and beverage industry, has been manager of record on a liquor license before, at the Boston University/Kenmore Square location. Wen had no issues with the local board or ABCC while manager of record and is familiar with the rules and regulations of the Board, ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Wen provided proof of training in the safe service and sale of alcohol from 360 Training.

Decision: Granted (2-0), including with the amendment to include the outdoor area in the licensed premises (provided updated ABCC application is submitted).

4. Application #1138797 Arrow Street, LLC d/b/a Arrow Street, 0 Arrow Street, Entertainment License #257794, for a new General On Premises All Alcohol License. Jessica White and proposed Manager of Record of a premises described as: 3,500 square feet located on the first floor theatre in the lobby (800 sq. ft.), the studio (900 sq. ft.), and the theatre (1,800 sq. ft.).

Present: Tyler Henseler; and Jessica White.

Documents Considered: Application and documents attached thereto. Letter in support of application from Harvard Square Business Association ("HSBA").

Summary: Currently holds an entertainment license, which includes the outdoor area. They are not seeking alcohol on the outdoor area at this time because of some zoning issues, so limiting the area, but may be back for the outdoor service. Applicant asserted the public need is strong; it is a theater venue and operates as non-profit. Right in Harvard Square, previously the Oberon Theater and can accommodate any performance. Harvard Square has missed the unique space since 2021 and they will provide what used to be Oberon. The alcohol will enhance the public experience and that is the trend in the industry and the patrons have asked for it.

Jessica White has experience in the food and beverage industry and has been the manager of record on a liquor license before with no issues with local board or ABCC. White is familiar with the rules and regulations of the Board, ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. White will provide TIPS Certificate as proof of training in the safe service and sale of alcohol.

The Board acknowledged receipt of letter in support of application from HSBA.

Decision: Granted (2-0).

The back area is closed off from the front and used as kitchen/storage. There is exit at the front and back of the unit. Speakers in the ceilings used for the background music.

Summary/Decision: Matter continued as the application was incomplete.

Summary: The applicant is seeking to have a DJ and live music of a 1 and 2/3 piece and live music for brunch. This would be more of a social experience for their guests to enjoy. It will also be used to host small weddings.

Decision: Granted, with the condition that to accommodate the entertainment, they must remove all tables and chairs in meeting room 104, and the 10 person table and corresponding chairs in the dining area.

Application #1143208 Nick Anderson, Turner Construction, for a Special Noise Variance from 12/2/24-5/31/25 (No alternate dates), at 123 Broadway, 6:00 a.m. – 7:00 a.m. Monday through Friday, and 7:00 a.m. – 9:00 a.m. on Saturday. For loading trucks and soil hauling using hand tools, trucks, generators, excavators, and digging cranes. The variance is sought to complete the full scope of work and ensure public safety.

Summary: This is the MXD project, digging out substation 20-30 trucks on site at 7:00 a.m., ready to get hauling. For public safety and traffic, to move the trucks in earlier, they want to start loading at 6:00 a.m. to alleviate pressure to the area. They would not be using it every Saturday but it would be to get them out earlier. If granted, they would start the digging at the new allowed variance hour. The site is right in the middle of their site and they do not believe it would be disruptive to the abutters.

The Board questioned whether abutters had been properly noticed as the affidavit mentioned a list of abutters but there was no list attached. There are many residences nearby, and the Board questioned whether the applicant had proved an undue hardship of complying with the Ordinance.

Decision: Denied.

10. Disciplinary Burns Landscape & Snow Management, Leaf Blower Permit #218160, for allegedly simultaneously operating multiple leaf blowers within 100 feet of one another on October 8, 2024 and October 22, 2024, at 145 Brattle Street in violation of CMC 8.16.081.3(10).

Present: Investigator Tyler Bubenik; and Damon Krukowski, complainant. No one appeared for the company.

Documents Considered: Hearing notice and documents attached thereto.

Summary: [11:44 a.m.] Complainant lives across the street from the parking lot of the site, which is a Church. Burns Landscape has been their provider for years, and for years have violated the ordinance. The ongoing issues are operating during the season ban, operating multiple blowers side-by-side, etc. On October 8, when they were operating side-by-side Krukowski went to speak to the crew, and as typical, they were dismissive of him. Hence, Krukoswki called the police. Then the same situation happened on the 22nd. The operators, on each instances, were about 3 to 4 car lengths from each other.

Decision: Violation (2 counts), \$300 fine per violation and \$100 hearing fee for failure to appear, for total fines of \$700. There will be notice to property owner who will also be cited for a disciplinary hearing if future violations are alleged.

11. Disciplinary Faro Cafe, LLC, d/b/a Faro Cafe, 5 Arrow Street, General on Premises License #257102 and Common Victualler with Entertainment License #167168, for allegedly operating over the licensed capacity and providing entertainment without a license, on October 18, 2024, in violation of M.G.L. c. 138, §§ 23, and 64; c. 140, § 183A, and Rules and Regulations of the City of Cambridge Board of License Commissioners Rules 2, 5.1, and 9, 10, 11, and 14.

Present: Investigator Tyler Bubenik; Henry Hoffstot, owner; Jonathon Green; and Laura Cere.

Documents Considered: Hearing notice and documents attached thereto.

Summary: Based upon receipt of complaints as to the manner in which the business was being conducted, Investigator Bubenik conducted an inspection of Faro Cafe at approximately 10:55 p.m. on Friday, October 18th. Upon arrival, Investigator Bubenik noted a small line in front of the business and a crowded interior with amplified music playing. Investigator Bubenik asked the door person as to the number of people inside of the establishment, to which they responded that they did not know exactly. Inside, Investigator Bubenik counted 48 individuals and observed a DJ playing music. Faro has a capacity of 24, and is not licensed for DJ entertainment.

Investigator Bubenik spoke with a staff member and communicated that Faro was both operating over capacity and providing unlicensed entertainment. They responded that they would stop the event. The DJ stopped and individuals inside began to exit the establishment bring the capacity to compliant levels. By a few minutes after 11:00, the business was clear of patrons entirely.

While Investigator Bubenik was completing the inspection form, they asked the same door person if they knew what the licensed capacity for the interior was, but they were unable to answer. Investigator Bubenik also spoke with owner and Manager of Record Henry Hoffstot. Hoffstot told Investigator Bubenik that they believed the interior maximum capacity was higher than 48 and stated that they could provide documentation. Nothing was produced, and ultimately Hoffstot told Investigator Bubenik that this conclusion appeared to have been made in error.

Investigator Bubenik testified there is a history of noise complaints associated with the business, mainly regarding the level of music emanating from the premises. In particular, the License Commission received reports from an office across Arrow Street stating that the music was disruptive to their business and another from a representative of a condo association on Massachusetts Avenue saying the entertainment hours and level, in conjunction with Faro's windows frequently being open, was disturbing to its inhabitants. Investigator Bubenik also noted for the record that morning they received an email from a representative of the office across the street suggesting the issue of noise had been resolved to their satisfaction. Investigator Bubenik testified that on the night of October 18th, the music was not *plainly* audible 50 feet from the building.

Hoffstot testified they understand regulations and had implemented stricter controls and provided additional training to staff and are operating responsibly. Hoffstot stated they have an immense pride in that they are providing an establishment where people can reconnect and gather. It is their intent to reinvigorate the City and have even gotten feedback that people have relocated to move closer to café. Hoffstot mentioned a few times how they are being a responsible neighbor and implemented measures to come into full compliance, but when questioned, only broad statements were being provided. Finally, Hoffstot mentioned they made sure employees knew the capacity limits and they temporarily stopped operating in the evening, and will have a designated person responsible for head count. Hoffstot also mentioned they were confused how DJ was not part of the license.

The Board questioned Hoffstot's view of the incident and stance of "confusion" as to whether DJ was part of the currently licensed entertainment. The Board mentioned not finding Hoffstot's testimony credible and highlighted the seriousness of the offense of operating beyond licensed capacity. The Board also did not find credible the "argument" of not knowing what constitutes a DJ.

Decision: Granted.

Application #1143396 Stratton Donuts, Inc. d/b/a Dunkin', 84 Massachusetts Avenue, for a new Common Victualler License at a previously licensed location (same business, different ownership corporation). In one room on the first floor with kitchen and storage in the rear, 66 maximum sitting and occupancy and hours of operation of 7:00 a.m. – 10:00 p.m. Adriana De Nardi as manager of record.

Decision: Granted.

15. Application #1143204 Nick Anderson, Turner Construction, as an extension to Special Noise Variance #283845, for 12/2/24 - 2/28/25 (Alt. 2/9/24 - 3/7/25), at 290 Binney Street, from 6:00 p.m. to 11:00 p.m. Monday through Friday, to receive deliveries and perform shakeout and installation of materials, using cranes, hoisting equipment, material hoist, trucks, and generators. The variance is sought in the interest of public and worker safety, as well as limiting impacts to vehicular and pedestrian traffic.

Decision: Granted with the condition that cannot be exercised on the eve or day of any legal or City observed holiday.

16. Application #1143207 Nick Anderson, Turner Construction, as an extension to Special Noise Variance # 283968, for 12/7/24 - 3/8/25 (Alt. 12/14/24 - 3/15/25), at 123 Broadways, from 7:00 a.m. to 11:00 p.m. (variance hours 7:00 a.m. -9:00 a.m. and 6:00 p.m. -11:00 p.m.) on a total of ten (10) Saturdays, to perform concrete slab pours, using hand tools, concrete trucks, cranes, concrete pump truck, generator, and concrete finishing equipment. The variance is sought both to extend the day to accommodate the full scope of work, and limit impacts to vehicular traffic during a required roadway shutdown.

Decision: Granted with the condition that cannot be exercised on the eve or day of any legal or City observed holiday.

17. Application #1143205 Nick Anderson, Turner Construction, as an extension to Special Noise Variance # 283956, for a Special Noise Variance from 12/2/24 -3/2/25 (No alternate dates), at 290 Binney Street, 7:00 p.m. to 5:00 a.m. all days, for utility work using generators, excavators, hoisting and rigging equipment, vac trucks, and small hand tools. The variance is sought to extend the workday to complete the full scope of work and to ensure public safety.

Decision: Granted with the condition that a Sunday work permit is required, and the variance cannot be exercised on the eve or day of any legal or City observed holiday.

18. Application #1143337 Rob Rego, J Derenzo Copay, for a Special Noise Variance from 12/12/24-12/13/24, (Alternate dates 12/10/24-12/11/24), at 55 Broadway, from 9:00 p.m. – 7:00 a.m., for removing a section of water main and replacing with new pipe using a rubber tire excavator, Generator, and chop saws. The variance is needed due to the work needing to be completed at night during water shutdown.

Decision: Granted.

19. Application #1144195 Central P&I, Inc. d/b/a Cambridge Italian Pizzeria, 1621 Cambridge Street, for a new Common Victualler License at a previously licensed location. Approximately 2,200 sq. ft. with 1,455 sq. ft. customer area. Front entrance for customers, back entrance for employees. Includes basement level for storage with walk-in coolers. Bathrooms on first floor. 18 seats with maximum occupancy of 24. Beshara Ibrahem as one of the owners and manager of record. With hours of operation of 10:00 a.m. – 10:00 p.m. Monday – Saturday (closed on Sundays).

Decision: Granted.

20. Board Acknowledgement [Matter Heard September 9, 2024 and decided September 24, 2024] Middle East Restaurant, Inc. d/b/a Middle East, 472 Massachusetts Avenue, All Alcohol Common Victualler and Entertainment License #11691, withdrew their appeal of the two day suspension issued for failure to call for medical or police assistance on April 27, 2024, G.L. c. 138, §§ 23 and 64 and Board's Rules 2, 8.1(b) and 8.2. The suspension was served November 12 and 13, 2024.

Decision: Acknowledged.

21. Board Acknowledgement Boston BBQ Company, LLC d/b/a Smoke Shop, One Kendall Square #100, Common Victualler All Alcohol License #11537, has closed and surrendered its license.

Decision: Acknowledged.

22. Board Acknowledgement Super Target Liquor of Massachusetts, Inc. d/b/a Target, 564 Massachusetts Avenue, Package Store Malt and Wine License #12982, has ceased alcohol sales and surrendered its license.

Decision: Acknowledged.

23. Board Acknowledgement President & Fellows of Harvard College d/b/a Cambridge Queen's Head Pub, 45 Quincy Street, Educational All Alcohol License #11622, has ceased operating, the license is surrendered.

Decision: Acknowledged.

24. Board Acknowledgement Bon Me Foods, LLC d/b/a Bon Me, 222 Jacobs Street, Common Victualler with Malt License #256214, has decided not to renew the liquor license and allow it to naturally lapse on December 31, 2024, will continue to operate as a Common Victualler License only in 2025.

Decision: Acknowledged.

25. Consideration of Waiver of Hearing – Disciplinary Matter Property Ownership of 145 Brattle Street, accepting two violations of CMC 8.16.081.3(10), operating leaf blowers within 100 feet of each other, by Burns Landscape & Snow Management on October 8 and 22, 2024 at 145 Brattle Street.

Decision: Violation, 2 counts, \$300 fine per violation for total fine of \$600.

26. Board Vote [Disciplinary Matter Heard October 9, 2024] Interstate Management Company, LLC d/b/a The Charles Hotel, 1 Bennett Street, Innholder All Alcohol License #10894, allegedly serving, selling, or delivering alcohol to an intoxicated individual and/or overservice of alcohol on January 31, 2024 and February 1, 2024, in violation of G. L. c. 138, §§ 23, 64-64A, 69, G. L. c. 140, and Board's Rules 2, 12B.6, and 12B.7.

Summary: The Board discussed how at the hearing there was a lot of emphasis on what the business did in terms of calling emergency personnel. They were not cited for failure to call police/emergency personnel. They were cited for overservice of alcohol or service to an intoxicated patron. It is clear that someone who throws up on the bar and is seen in such a state that the security personnel is worried for their safety when leaving with a co-worker was over served. The Board also raised the issue how the law of overservice is not based on common sense. The Board did believe it was clear something went wrong in terms of service, but based on the impossible parameters set by state or case law regarding these cases, there would not be enough evidence to sustain the charge. The Board did raise that they testified as to a policy regarding the bartenders communicating and change of shift procedures, and landed no obtaining more information on that policy as well as obtaining all training certificates as required by Rule 5B.10.

Decision: No violation – business must provide written explanation of policy regarding shift changes and communication between bartenders when serving the same patrons/tab/area, and all certificates of proof of training must be provided within 14 days of the decision being issued.

27. Board Vote [Informational Matter Heard October 29, 2024] DMG Food Enterprises, LLC d/b/a 730 Tavern Kitchen & Patio, 730 Massachusetts Avenue, Common Victualler All Alcohol License

#11613, addressing business practices related to the purchase, possession, obtainment, and consumption of alcohol by underage individuals; removal of alcoholic beverages from the licensed premise; as well as disturbances stemming from noise, patron behavior, and crowd management issues.

Summary: The Board discussed how it is clear something is going on with the business when investigators are getting pictures of people on the street with cups in hand and complaints about underage drinking, etc. It is also very telling that when the investigators walked in, there were 150 patrons (per the establishment) and as soon as the investigator started to check identifications, the count went to 20. Patrons ignoring requests from the investigator and leaving rather than producing identifications is also very telling and concerning. The Board noted it was aware none of these issues are sufficient to establish a violation, but that it puts everyone on notice, including the business, that they are not running the place appropriately. The business did provide evidence of hiring an outside consultant, who used to work for the ABCC, and some measures they have implemented. Regardless, that is not enough. There has to be a history of these items working, or of these issues and complaints dissipating.

Decision: Continue the case for three months, and have a follow up information hearing then.

28. Board Vote [Deferred from October 9, 2024 Hearing] Application #1138790 (p/k/a 280604), Pyramid Cambridge Management, LLC d/b/a The Kendall Hotel/Kendall House/Black Sheep, 350 Main Street, to transfer the existing All Alcohol Innholder License (#10896) held by The Firehouse Inn, LLC at the same location. Shannon Keefe as proposed Manager of Record of a premises described as: Hotel with 8 floors, including garage, and 77 rooms for a total square footage of 40,508. Includes dining room, kitchen, and bar on 2nd floor. Storage in basement. Spa and conference room on 7th floor. Outdoor patio on 1st floor and outdoor roof deck on 7th floor.

Summary: A corrective application was filed and is pending (although the ABCC has requested supplemental information on it). As to this application, we requested additional documents which were only provided last week. There is also an affidavit from the landlord – MIT – missing stating they have no interest in the license. Regardless, the Board noted the application was sufficiently complete for a vote and that it would be best to send it to the ABCC so they could review it in tandem with the pending corrective application.

Decision: Granted, send to the ABCC for final approval once the MIT affidavit is provided.
