## **Applicant Must Initial Each Item**

1. I agree that I have no police powers under the State of Massachusetts or any other local governmental subdivision and have no authority to carry a weapon while performing my activity as an informant. \_\_\_\_\_
2. I acknowledge that I am associated with the Cambridge Police Department as an informant on a case or time basis as an independent contractor and that any payment I receive from the Cambridge Police Department will not be subject to Federal or State Income Tax Withholding or Social Security. All reporting of income is the responsibility of the informant. \_\_\_\_\_
3. I further acknowledge that as an informant and independent contractor, I am not entitled to Workmen's Compensation or Unemployment Compensation from the State of Massachusetts and I shall not hold Middlesex County liable for any injuries or damage incurred by reason of my association with the Cambridge Police Department. \_\_\_\_\_
4. I further agree not to divulge to any person, except the investigator with whom I am associated, my status as an informant for the Cambridge Police Department unless required to do so in court and shall represent myself others as an employee or representative of the Cambridge Police Department. \_\_\_\_\_
5. I further agree that I will not participate in any criminal investigation, unless it is supervised by a member of the Cambridge Police Department. \_\_\_\_\_
6. I further agree that I will not participate in any criminal activity, unless I am directed to do so by the investigator with whom I am associated (any unsanctioned criminal activity may very well subject me to criminal prosecution). \_\_\_\_\_
7. I further agree to report to investigator with whom I am working any contact I may have, or any nature and in any capacity, with other law enforcement officers. \_\_\_\_\_
8. I further agree not to use the Cambridge Police Department or any of its officers as credit references or employment references unless prior approval is obtained from the investigator with whom I am associated. \_\_\_\_\_
9. I further agree that my association with the Cambridge Police Department does not afford me any special privileges. \_\_\_\_\_
10. I further agree that after making a purchase of anything of evidentiary value, I will contact the investigator with whom I am associated as soon as possible for delivery of such evidence to him/her. \_\_\_\_\_

11. I further agree to maintain strict accounting of all funds provided to me by the Cambridge Police Department as part of my activity as an informant. I understand that misuse of county funds could be grounds for criminal prosecution against me. \_\_\_\_\_
  
12. I further agree not to reveal to anyone, the identity of any law enforcement officer, the existence, nature, or content of any investigation, or the methods or investigative techniques of law enforcement, unless ordered to do so by a judge in a court of law. \_\_\_\_\_
  
13. Finally, I agree that violation of any of the above enumerated provisions will be grounds for immediate termination and probable criminal charges. \_\_\_\_\_
