ED Schlacter, CHRC staff, Commissioners Selk and Leydon participated in poster making events at the Cambridge Public Library to collect submissions for the 2016 Fair Housing Poster Contest. ED Schlacter and AI Acloque attended a quarterly Brown Bag meeting regarding Fair Housing issues at Suffolk University Law School. Administrative Coordinator Rosa attended an introductory meeting on GIS training provided by the city's GIS Department.
