Board of License Commissioners Board Members Present: Nicole Murati Ferrer, Gerard Mahoney and Branville Bard.

Staff Present: Elizabeth Y. Lint, Executive Director.

Public Testimony Matters:

 Application North Point II Apartments, LLC has applied for a Garage License at 2 Leighton Street and 3 and 5 Glassworks Avenue for 212 parking spaces and approximately 3,200 gallons of gasoline in the tanks of autos only.

Present: John Gelcich and Mary Kate Daly, applicants.

Documents Considered by The Board: Application and documents attached thereto, also revised application filed at the hearing.

Summary: This garage is for residential use only. They expect to receive their temporary certificate of occupancy this month with completion of the garage in the spring. Original application was for 3,200 gallons of gasoline as applicants calculated 15 gallons per vehicle. However, applicants filed revised application at the hearing to conform with the standard calculation of 10 gallons per vehicle.

Decision: Granted (3-0) amended application (total of 2,120 gallons).

2) Application North Point II Apartments, LLC has applied for a Garage License at 2 Leighton Street and 3 and 5 Glassworks Avenue for 212 parking spaces and approximately 3,200 gallons of gasoline in the tanks of autos only.

Present: Attorney Kevin Crane and Jamme Chantler, applicant.

Documents Considered by The Board: Application and documents attached thereto, signatures in support of application (submitted at the hearing).

Summary: Mr. Chantler has been operating at this location for seven (7) years. He expanded the premise three (3) years ago. Now wants to further expand to the left (would be taking over a now vacant space). The current capacity is 91 and the proposed new capacity would be 190. ISD has not yet reviewed the proposed new floor plan or capacity. The business would remain the same except that the new portion would not offer the jazz music (thereby providing further options to the customers). The right and left sides connect through a wall cut through.

The ABCC application indicates the applicant owns the space. It was confirmed at the hearing that the applicant leases the space.

There was discussion of the end time for entertainment. It was amended last year to bend at 1:00 AM and not 11:00 PM. However, the renewal had the end time at 11:00 PM.

Decision: Granted (3-0), and final occupancy to be determined after ISD reviews and approves the floor plan. Also, the Board will send a note to the ABCC noting that the space is leased not owned. Entertainment License is confirmed to end at 1:00 AM.

3) Application La Fabrica Central, LLC d/b/a La Fabrica, holder of a Common Victualler All Alcohol License and Entertainment License at 450 Massachusetts Avenue, has applied for a Change of Manager to Renato Rodrigues and a Change of Closing Hour to 2:00 a.m. seven days per week.

Present: Renato Rodrigues; Nivia Pina and Attorney Sarah Hunt.

Documents Considered by The Board: Application and documents attached thereto.

Summary: Mr. Rodrigues was the manager at Monroe. However, he left the establishment prior to their problems with the Board. When he ceased being the manager of Monroe, he informed the Board. He was also the manager of record of an establishment in Boston. While manager of record, the businesses did not receive any suspensions or disciplinary action from the respective local boards or the ABCC. Mr. Rodrigues is TIPS certified.

La Fabrica presented that there is a public need for a 2:00 a.m. seven days a week as it is a request being made by persons/entities attempting to host private events in the back room. For example, Harvard, MIT and some local industries have both decided not to book events at the location because the night would "end too early" with a 1:00 a.m. Current manager of record and owner Ms. Pina confirmed La Fabrica, based on recent issues with their Thursday night events, has eliminated the Thursday college night. La Fabrica continues to cater and seek to cater to a more upscale, professional clientele. The later closing hour allows La Fabrica to serve employees who work in the area and leave work late.

Decision: Granted (3-0) pending payment of the hearing and CORI fee (\$110.00).

4) Application Sheger Café and Ethopian Restaurant, LLC has applied for a new Common Victualler Wine & Malt Beverages License at 2376 Massachusetts Avenue. Misrak Gandi as Proposed Manager of Record of a premise described as: approximately 1500 SF on the street level of Massachusetts Avenue with a bathroom, kitchen, and storage and 32 SF patio on public property. Proposed hours of operation are: 9:00 a.m. to 10:00 p.m. Monday through Saturday and 11:00 a.m. to 9:00 p.m. Sunday with a seating capacity of 44 inside and 8 outside on a seasonal public patio.

Present: Misrak Gandi and Zemene Afework.

Documents Considered by The Board: Application and documents attached thereto.

Summary: The applicants, husband and wife, were approved for a common victualler ("CV") license earlier in 2017 but the license has not issued. The applicants are still developing the space. Also, although in the previously approved CV application the applicants noted that they would not seek an alcohol license, at the hearing, they clarified it was always their intent to seek an alcohol license. Both have restaurant experience in their native country but this would be their first business in the US. Based on the application responses and documents, it was unclear whether both would have a beneficial interest in the license. Applicants orally represented that the ownership would be 50% each. In addition, although there is no pledge, there are two loans associated with the transaction and some personal bank funds involved.

The applicants highlighted this would be the only Ethiopian restaurant in Cambridge.

Decision: Based on the responses at the hearing, the matter was deferred (3-0). The Board will consider the application once the applicants submit: (1) statement disclosing each individual's ownership interest; (2) proof of the loans disclosed in the application; and (3) three months of bank statements for the cash being used. In addition, the applicants must submit the plan for the proposed outdoor seating.

Administrative Matters:

All the below listed matters are considered and voted upon by the Board without public testimony. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda.

5) Discussion Super Target Liquors of Massachusetts, Inc. d/b/a Target, 564 Massachusetts Avenue, regarding the sufficiency of having alcohol roped off during off-hours, or if there is a more stringent requirement.

Summary: The Board had approved the application for a package store license at the location. However, the Board deferred whether any conditions would be placed on the license regarding how the alcohol would be made unavailable during hours when it could not be sold but the store would be open.

The applicant had proposed "roping off" the area. The applicant also explained all employees would be trained and the machines programmed so that the sales could not be made during non-legally allowed hours. The Board determined that based on the location of the store, the location of the alcohol in the store, and the character of the area, roping off would be insufficient. The Board imposed (3-0) the conditions that the alcohol in the coolers had to be locked during off hours and the aisles had to be gated. The Board commented that as an example, the means used by Star Market could be used as an example of proper "blocking/locking" mechanisms.

6) Shannon Liss-Riordan has notified the Commission that the Just Crust will not renew their license.

Decision: Acknowledged (3-0); license will expire December 31, 2017.

7) Hanna Sortino, holder of license number PED10078, has requested a change in d/b/a to The Little Blue Bakery.

Decision: Granted (3-0).

8) Approval of Renewals submitted (list will be presented at the hearing).

Summary: 102 Alcohol renewals submitted and 60 non- alcohol submitted.

Decision: Approved (3-0) – see attached list. Notation made on the record that some may be duplicates from previous hearing based on the way the new system runs reports.

9) Requests for Extension of Hours on New Year's Eve (list will be presented at the hearing).

Decision: Granted (3-0) as to all – see attached list.

10) Administrative Acknowledgements/Changes/Corrections based on information submitted with renewal applications (list will be presented at the hearing).

Decision: Granted (3-0) as to all – see attached list.

11) Non-renewals expiring on December 31, 2017:

Summary: Acknowledged as to all (3-0). See attached list.

One Day License Applications:

These applications are also considered administratively and there is no public testimony taken or requested. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda. In addition, the documents considered by the Board are the one day application submitted by the applicant and any other supporting document attached thereto. Police detail is required on some based on the recommendation of the signing-off police department.

1) Alexandra Photopoulos, has applied for an all alcohol license to be exercised at Gallery 263, 263 Pearl Street, on 12/15/17 from 7:00 p.m. – 10:00 p.m. for a fundraiser. Expected attendance -50 people.

Decision: Granted (3-0), with the condition that alcoholic beverages must be sold or there must be a limited number of alcoholic drinks associated with admission charge.

2) Jonathan Polep-Saffer, has applied for an all alcohol license to be exercised at 675 W. Kendall Street, on 12/31/17 & 1/1/17 from 9:00 p.m. – 2:00 a.m. for a charity gala with patrons dancing, recorded/live music, amplification system, light show and dynamic audio/visual show live/recorded. Expected attendance – 400 people.

Decision: Granted (3-0), noted that the approved January 1 event is in 2018.

3) William Fuller, on behalf of the Bartending Service of New England, has applied for a malt and wine license to be exercised at Harvard University, Old Yard, Boylston Hall-Ticknor Lounge, on 2/9/18 from 6:00 p.m. – 9:00 p.m. for a reception. Expected attendance – 120 people.

Decision: Granted (3-0), with the condition that a police detail is required.

4) Charles Clark, has applied for a wine with entertainment license to be exercised at Longy School of Music, 27 Garden Street, on 12/13/17, 2/15/18, 3/7/18, 4/11/18 and 5/2/18 from 6:00 p.m. – 8:00 p.m. for a reception with recorded/live music. Expected attendance – 30 people.

Decision: Granted (3-0), with the condition that alcoholic drinks must be sold or there must be a limited number of alcoholic drinks associated with the admission charge.

5) Bill Manley, on behalf of the Harvard Square Business Association, has applied for an entertainment license to be exercised at Brattle Plaza, on 12/9/17 from 12:30 p.m. – 2:30 p.m. for a food tasting event with patrons dancing, recorded/live music and amplification system. Expected attendance – 250 people.

Decision: Granted (3-0).

6) Jennifer Sur, has applied for a vendor's license to sell cd's, cards, books and ornaments at Sanders Theatre, 45 Quincy Street. [See attached application for dates]

Decision: Granted (3-0).

7) Reverend Aleksandar Vlajkovic, on behalf of St. Sava Serbian Orthodox Church, has applied for a malt and wine license to be exercised at St. Sava Serbian Orthodox Church, 41 Alewife Brook Parkway on 12/9/17 and 12/10/17 from 7:00 p.m. – 12:00 a.m. and 12:00 p.m. – 3:00 p.m. (respectively) for a 25th anniversary banquet.
