INVITATION TO BID

The City of Cambridge, Massachusetts, the Awarding Authority, invites sealed bids for the project: **Citywide Colored Surface Treatment for Pavement**

Nature and Scope of Work: On-call furnishing and installation of colored surface treatment at designated work locations within the City of Cambridge. Colored surface treatment is used on bus, bike, pedestrian facilities. Work consists of maintenance of existing facilities and installation of new facilities.

Bidding procedures shall be in accordance with M.G.L. c. 30, §39M, as mostly recently amended, and all other applicable laws.

The estimated project value is: **\$ 75,000.00.**

Plans and specifications will be available beginning from **Thursday August 8, 2024.** Please email purchasing@cambridgema.gov for an electronic copy.

The contract documents may be examined by appointment at the Office of the Purchasing Agent, 5 Bigelow Street, Cambridge, MA 02139.

Sealed general bids will be received at the Purchasing Department, **5 Bigelow Street**, Cambridge, MA 02139 during normal business hours prior to **2:00 PM Thursday August 22, 2024.** All general bids will be publicly opened and read aloud at City Hall, 795 Massachusetts Ave., Ground Floor Conference room, Cambridge, MA 02139.

Sealed general bids being delivered via USPS may be mailed to City Hall 795 Massachusetts Ave., Cambridge MA 02139 Attn: Purchasing.

Bids not delivered directly to the Purchasing Department may be dropped off to a grey locked drop box labeled "Purchasing" located at the rear entrance of City Hall. The box will be checked at the scheduled submission deadline.

All **questions** must be submitted in writing and either emailed to purchasing@cambridgema.gov or delivered to the Office of the Purchasing Agent, Elizabeth Unger, during normal business hours to 5 Bigelow Street, Cambridge, MA 02139 not later than **Thursday, August 15, 2024 by 2:00 PM. An addendum will be issued to notify all bidders of the questions and answers.**

All general bids shall be accompanied by a bid deposit in the form of a certified, cashier's or treasurer's check issued by a responsible bank or trust company made payable to the City of Cambridge or a bid bond, in an amount not less than five percent (5%) of the value of the bid.

The successful general bidder will be required to furnish a (Payment) Bond in the amount of fifty percent (50%) of the contract sum. Bonds shall be obtained from a surety licensed

to do business in the Commonwealth of Massachusetts and the form shall be satisfactory to the City of Cambridge.

The successful bidder will also be required to comply with the provisions of Chapter 306 of the Acts of 2004 in regard to required OSHA approved safety & health training.

The City of Cambridge reserves the right to reject any or all general bids if it is in the public interest to do so.

No less than the prevailing wage rates as set forth in the schedule contained in the Contract Documents must be paid on this project.
